Exercise of options in Unibet Group plc

In the exercise window ending on 15 November 2015 under the rules of Unibet Group plc Executive Option Scheme, 1,695 share options were exercised using SDRs from the Unibet Group's Share buy-back programme initiated in 2007 and 2011. In connection with this exercise, Unibet has received SEK 320,355 which has, in full, been taken to equity.

Following this exercise, the total amount of shares outstanding in Unibet Group plc is 28,764,630 ordinary shares with a par value of GBP 0.005. Of the total outstanding shares, 62,551 from the Share buy-back programmes initiated in 2007 and 2011 continue to be held by the Unibet Group.
